

CONTEST RULES

1. **CONTEST AND SPONSOR:** The oldest water heater contest (the “**Contest**”) is being sponsored by OKC Plumbing Inc., an Oklahoma corporation, doing business as Benjamin Franklin Plumbing of Oklahoma City (“**Sponsor**”).
2. **CONTEST PRIZE:** The Contest prize is an electric or gas tank-style water heater not exceeding 50 gallons to be furnished by Sponsor to replace the electric or gas tank-style water heater of similar size and capacity of the winning contestant, and the basic installation of the new water heater, permits, and removal and disposal of the old water heater by Sponsor (collectively, the “**Prize**”). Basic installation by Sponsor does not include any additional costs and expenses for goods and services required to bring the installation of the Prize by Sponsor into compliance with existing building, mechanical and electrical codes, if any. The winning contestant will be responsible for payment of those additional costs and expenses required for compliance. Sponsor estimates the value of the Prize to be up to \$3,800.00. The Prize has no cash value, and the winning contestant cannot exchange the Prize for cash or anything else. The Prize will be subject to any applicable manufacturer’s warranties, if any. **EXCEPT FOR THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE UNDER OKLAHOMA LAW, NO WARRANTIES OR REPRESENTATIONS ARE BEING GIVEN OR MADE BY SPONSOR, WHETHER EXPRESSED OR IMPLIED, CONCERNING THE PRIZE.**
3. **CONTEST ELIGIBILITY:** No purchase of goods or services from Sponsor is required to enter the Contest. To be eligible for the Contest, (a) a contestant must be a resident of the State of Oklahoma who (i) is at least eighteen years of age, (ii) is not an employee of the Sponsor, a member of the immediate family of an employee of the Sponsor or a person residing in the same household as an employee of the Sponsor, (iii) is the owner of a single-family dwelling (but excluding mobile homes) located in either Oklahoma, Cleveland, Canadian, Logan, or Grady county, Oklahoma (the “**Residence**”), (iv) resides primarily at the Residence, and (v) is not marketing the sale of the Residence at any time during the Contest (an “**Eligible Contestant**”), and (b) the old water heater being entered into the Contest must be an electric or gas tanked-style water heater (but excluding power vented and tankless water heaters) that (i) is the primary water heater for the Residence, and (ii) is not in excess of 50 gallons (the “**Qualified Water Heater**”).
4. **CONTEST DEADLINE:** Sponsor will cease taking entries for the Contest 5:00 p.m. CST on February 23rd, 2026 (the “**Deadline**”). Entries after the Deadline will not be eligible to participate in the Contest.
5. **HOW TO ENTER CONTEST:** An Eligible Contestant may enter his or her Qualified Water Heater in the Contest prior to the Deadline by providing his or her name, address, telephone number and email address to Sponsor either by telephone at (405) 336-1776, or by emailing to info@benfranklinokc.com. No more than one entry may be made by any contestant, or for any Residence or Qualified Water Heater. **BY**

ENTERING THIS CONTEST, A CONTESTANT IS AGREEING TO ABIDE BY AND BE BOUND BY THE TERMS OF THESE CONTEST RULES.

6. **SELECTION OF WINNER:** Sponsor will inspect the Qualified Water Heaters of the Eligible Contestants at no cost to determine the age by serial number. If an Eligible Contestant fails to permit or timely schedule the inspection of his or her Qualified Water Heater, he or she will be disqualified from the Contest. A contestant will also be disqualified from the Contest if he or she supplied inaccurate or false information to Sponsor or if Sponsor determines the contestant or his or her water heater does not satisfy the eligibility requirements. If two or more Qualified Water Heaters are determined by the serial numbers to be the same age, the earliest entry for those Qualified Water Heaters will be considered the oldest. The winner of the Contest will be the Eligible Contestant with the oldest Qualified Water Heater as determined by Sponsor in its sole and absolute discretion. The Sponsor's determination of the winning contestant will be binding and conclusive on all contestants. The winning contestant will forfeit the Prize if he or she fails to timely complete, sign and deliver to Sponsor the tax form described below. If forfeited, Sponsor will select a new winner of the Contest from the Qualified Water Heaters of the remaining Eligible Contestants under the foregoing selection process.
7. **INCOME TAX CONSEQUENCES:** The fair market value of the Prize will be considered income to the winning contestant under Federal and Oklahoma income tax law. Sponsor will issue an information return (IRS Form 1099-MISC) to the winning contestant. Prior to receiving the Prize, the winning contestant will be required to complete, sign and deliver to Sponsor an IRS Form W-9, Request for Taxpayer Identification Number and Certification. Failure to timely complete, sign and deliver that form to Sponsor will result in the winning contestant forfeiting the Prize and Sponsor will select a new winner of the Contest from the remaining Eligible Contestants.
